ENTRY LIMITS

There is a team entry limit of four (4) swimmers/divers per individual event. Each school is allowed to enter one (1) relay team per relay event. Each athlete is limited to entering four events, no more than two of which may be individual events.

ENTRY DEADLINE

The Meet Entry File is due to _____ by FRIDAY, OCTOBER 14, 2022 BY 5:00. Head coaches will be sent an email confirmation upon receipt of entries.

ENTRY NOTES

Coaches should enter swimmers/relays with best yard times, or NT. Coaches are required to send all swimming and diving entries using HY-TEK software.

Coaches are asked to use the provided meet entry file. It may be obtained from Quinn Sampson.

Entry files should include CURRENT USA-S numbers of any USA-S registered swimmer if coaches wish to have times entered into the SWIMS 3.0 database. Please note that USA-S IDs have been recently updated through USA Swimming. The newer IDs are randon 14-character ID.

Though not required, it is requested that coaches show school year (9, 10, 11, or 12) for each swimmer in their entry file.

TIMERS

All participating schools will be asked to provide two timers for the meet, each of whom will time for approximately two hours. The meet will be divided into two timing sessions, 9:00-11:00 and 11:00-1:00 (or meet conclusion) Timers will be admitted free of charge. Timing assignments will be sent to coaches before the meet. FAST will supply all timer equipment needs and lap counters.
