# ASSUMPTION OF RISK DISCLAIMER

### **MEET FORMAT**

This is a short course yards timed final meet with Qualifying Times. This meet will be <u>capped at 400 swimmers</u>. The cap may be exceeded only at the discretion of the Meet Referee.

Meet Management reserves the right to add breaks between events if deemed necessary. Breaks will be published in advance of the session and limited to 10 minutes. Events may be combined at the discretion of the Referee. All events will swim slowest to fastest unless noted.

#### **RULES**

This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional, and exceptions are stated.

TECHNICAL SUIT BAN Per USA Swimming Rule 102.8.1F, 12 & Under athletes may not compete in for 12&Us

Technical Suits at this meet.

A Technical Suit is one that has the following components:

- Any male or female suit with bonded or taped seams regardless of fabric or silhouette; or
- Any male or female suit with woven fabric extending to the knee or mid-thigh regardless of the seam type.

#### **MAAPP**

All adults participating in or associated with the meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Protection Policy ("MAAPP"), and that they understand that compliance with the MAAPP is a condition of participation in the conduct of this competition.

### **SAFE SPORT**

The Florida Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. Swimmers may be dropped off only in designated safe areas. Swimmers are not permitted in work out rooms, storage rooms, meeting rooms, or control rooms. No glass containers or bottles are allowed inside the facility at any time. Anyone failing to comply with a safety request may forfeit his or her privilege to participate. We strongly recommend each team assign a marshal to monitor warm-up sessions and locker rooms in addition to host team marshal.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms, or behind the starting blocks. Flash photography of any kind is prohibited at the start of a race.

Deck changes are prohibited.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of a backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. It is

also the responsibility of the swimmer or the swimmer's guardian to request assignment from the Meet Director to a USA Swimming member coach attending the meet if a coach from the swimmer's team is unable to attend.

Unless approved in writing in advance of the competition by the Program and Events Committee Chair or designee, operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, spectator areas, and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present.

Only swimmers, properly certified officials and coaches, and meet volunteers will be allowed on Deck. No spectators will be allowed on Deck at any time.

#### **ELIGIBILITY**

Open to 13-19yr old swimmers who are NOT competing for a college team nor have committed/signed with a college team. All swimmers must be registered with USA Swimming, Inc., and all Adult Athletes must hold current APT certification to compete. Swimmers must be registered prior to the entry deadline. There will be NO on-deck registration available at this meet. The 2021-2024 NAG Time standards are in effect for this meet. Swimmers must have achieved a "B" time in their age category for each event entered. No Time (NT) entries will not be accepted. A swimmer's age on the first day of the meet will determine their Age category for the meet.

# MEMBERS WITH DISABILITIES OR MEDICAL CONDITIONS

Titusville Swim Team welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Director by the entry deadline accompanying their meet entry file, including the need for any personal assistants required and/or registered service animals. Failure to provide advance notice may limit Titusville Swim Team's ability to accommodate all requests.

### **ENTRIES**

Accurate Swim Timing will be handling all entries. Entries must be in USA Swimming SDIF format or Hy-Tek CL2 format. Entries should be emailed to entries@accurateswimtiming.com. You will receive email confirmation within 24 hours of submitting your entries. Entry Deadline is Monday, April 10, 2023, at 5:00pm

NT entries will not be accepted. A completed and signed Entry Summary Sheet (included in the announcement) and payment in full must be received by the Meet Entry Coordinator no later than the first day of competition, or the participant(s) will not be removed from the meet. Titusville Swim Team entries will be entered first, and then accept teams/entries in the order received until the meet is full. Entries received after that will be returned immediately.

### **ENTRY LIMITATIONS**

Swimmers are limited to four (4) individual events per day and a total of eight (8) individual events for the weekend.

**ENTRY VERIFICATION** An email will be sent to the person submitting the entry confirming receipt of

the entry within 48 hours of receipt.

**ENTRY DEADLINES** The Meet Entry Coordinator must receive entries by the date and time listed

in the Deadline and Meeting Summary above. Late entries will not be accepted as determined by the meet referee. There will be no on-deck

entries.

### **ENTRY FEES**

**SEEDING** The conforming time standard for this meet is short course yards. Swimmers

will be seeded and swim from slowest to fastest unless otherwise indicated.

Non-conforming times will not be accepted.

**CHECK-IN** Events 400 yards/meters and longer are positive check-in events. Swimmers

who fail to check in by the deadline will be scratched from the event. A

swimmer who is properly checked-in, seeded, and fails to complete in said event

shall be barred from their next event.

A positive check-in will be required for the following events.

Event 11 & 12 500 Free Closes Saturday April 22 at 8:30am Event 23 & 24 400 IM Closes Sunday April 23 at 8:30am

- 400 Yards IM: The 400 Yard Individual Medley will be Deck seeded
  after positive check in. It will be swum fastest to slowest alternating
  women and men. Heats and events may be combined at the
  discretion of the Meet Referee.
- 500 yard Free: The 500-yard freestyle free will be Deck seeded after
  positive check in. It will be swum fastest to slowest alternating
  women and men. Heats and events may be combined at the
  discretion of the Meet Referee. Swimmers must provide their own
  counters.

**SCRATCHES** 

There will be no penalty for scratching pre-seeded events at the block.

**SCORING** 

There will be no scoring.

**AWARDS** 

There will be no ribbons at this meet.

**RESULTS** 

Results will be posted on Accurate Swim Timings website within 24 hours of the conclusion of the meet. At the conclusion of the meet, teams may obtain Hy-tek backups either on a memory stick or via email attachment.

**COACHES** 

All coaches on deck must be registered and certified with USA Swimming. Meet Management will require all coaches to show proof of certification/registration and shall prominently display their registration cards or have easy access to their Deck Pass virtual membership cards at all times while on Deck. There will be a general meeting at the date and time listed in the Deadline and Meeting Summary above. Other meetings may be held at the meet referee's discretion.

Meet Management requests that at least one coach representative from each team attend all coaches' meetings.

# OFFICIALS/TIMERS/VOLUNTEERS

There will be a need for officials. Any official's assistance will be greatly appreciated and will help to ensure a great meet for the swimmers. Titusville Swim Team welcomes and encourages anyone willing to Officiate to contact the Meet Referee by email prior to the meet. All officials on Deck must be registered and certified with USA Swimming and show proof of certification/registration to the meet referee or designee by displaying their registration card or be prepared to show their Deck Pass virtual membership card upon request.

Official briefings will be held in the hospitality area at the date and time listed in the Deadline and Meeting Summary. Meetings may be virtual in advance, and assignments may be communicated electronically before each session. All officials are strongly encouraged to complete a personal review of applicable USAS rules before the meet. Officials should report at the time specified by the Meet Referee and bring a mask (if necessary) and a writing utensil. While Titusville Swim Team strives to provide all the timers, there may be a need for volunteers from other teams to time. Timers should report to the head timer on the pool deck 30 minutes prior to the start of the session.

## HOSPITALITY/ CONCESSIONS

There will be a hospitality area open to all coaches and officials.

#### **WARM-UP**

In accordance with USA Swimming guidelines, there will be a published warmup procedure for all swimmers and coaches attending the meet. The Marshal will ensure all teams, coaches, and swimmers follow all warm-up procedures. Meet Management reserves the right to change warm-up times according to the number of entries. Warm-ups will be divided into two (2) sessions, each approximately 40 minutes in duration. All warm-up information will be distributed via email prior to the start of the meet. All procedures will be established and announced during the Coaches/General Meeting as indicated in the Deadline and Meeting Summary above. During the competition, there will be lanes available for continuous warm-up/down. There is to be no diving or horseplay in this area.

### WAIVER/RELEASE

As a team entered in this meet, upon entry you are verifying that all of the swimmers and coaches listed and attending are registered with USA Swimming. You acknowledge that you are familiar with the Safety Rules of USA Swimming, Inc. and Florida Swimming, Inc. regarding warm-up procedures and meet safety guidelines and that you shall be responsible for the compliance of your swimmers with those rules during this meet. Titusville Swim Team, Rosen Aquatic Center, Florida Swimming, Inc., and USA Swimming, Inc., their agents, employees, and coaches shall be held free and harmless from any and all liabilities or claims for damages arising by reason of illness or injury to anyone during the conduct of this meet. You acknowledge that by entering this meet, you are granting permission for the names of any or all of your team's swimmers to be published on the internet in the form of Psych Sheets, Meet Results, or any other documents associated with the running of this meet.

#### **IMAGE RELEASE**

All participants agree to be filmed and photographed by the host club approved photographer(s) and videographers and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the host club or FLswim website or social media or in public broadcast of the event via television or webcast. Parents and guardians of minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their team's head coach and the Meet Director prior to the meet.
